Task 2: A study of an entrepreneur

To do well at A-Level Business you will need to develop certain skills. One of the main ones is to independently research different aspects of the course and be able to communicate your findings to the class as a whole. We therefore want you to conduct your own investigation into either a lesser known **business role model** or into a **business** of your choice. Possible questions you might want to answer include:

- Which business personality inspires you and why?
- What have they done in their career, give a brief history?
- Is their business a primary, secondary, or tertiary sector business?
- What does it do?
- Is it a private sector or public sector organisation?
- Who owns it and what does this mean for the business?
- What are their primary aims and do you think these are realistic?
- Who are their main competitors?
- How do they differentiate themselves?
- How do they measure success and how successful are they?
